## RESOLUTION IN SUPPORT OF THE CYPRESS CREEK GREENWAY PROJECT

WHEREAS, the Cv-Fair Houston Chamber of Commerce is committed to increasing the quality of life in the Cy-Fair area and said quality of life is positively impacted by parks, greenways, trails and waterways, where business owners and residents may enjoy walks or bicycle rides, canoeing, picnics and other forms of recreation.
